

INFORMATION CLAUSE ON PERSONAL DATA PROTECTION

Pursuant to Art. 13. 1 and Art. 13.2 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation) in connection with the cooperation to be established, in order to respect your privacy and ensure that you know who and how processes your personal data, please find below information that will help you to find it out.

1. The Controller of your personal data is Gozdrew Sp. z o.o. seated in Gościm, at the following address: Gościm 136B, 66-530 Drezdenko, registered in the Register of Entrepreneurs of the National Court Register, kept by the District Court in Zielona Góra, 8th Commercial Department of the National Court Register under the number KRS 0000407538, REGON No. 081005098, VAT No. 2810084024, BDO No. 000015734. As a Controller, we will process your data in order to conclude and perform the contract pursuant to Art. 6. 1.b of the General Data Protection Regulation for direct marketing (legally justified interest of the Controller) based on Art. 6. 1.f of the General Data Protection Regulation in order to fulfill the legal obligations imposed on the Controller on the basis of Art. 6.1.c of the General Data Protection Regulation in order to protect rights and pursue claims on the basis of Art. 6. 1.f of the General Data Protection Regulation.
3. You have the right to access your personal data and to receive a copy thereof, to correct it, to request their erasure, transfer or restriction of your data processing. You also have the right to object to the processing of personal data. Should you object, we will stop processing your data for the purposes specified, unless we can show that there are valid legal grounds for us that are superior to your interests, rights and freedoms or your data will be necessary for the establishment, exercise or defense of legal claims. To use your rights, please contact the Controller.
4. If you think that your personal data will be processed in violation of the legal requirements, you have the right to file a complaint with the supervisory authority, i.e. the President of the Office for Personal Data Protection.
5. Providing data by you is voluntary, but necessary for the conclusion and performance of the contract.
6. The recipients of your personal data will be those entities to whom we have the obligation to provide data in accordance with applicable law, as well as entities providing services supporting our contract performance, in particular accounting, legal, IT, transport, courier services, etc.
7. Your personal data will be processed by us throughout the period when the contract is being performed, and thereafter, i.e. until the expiry of the limitation period for possible claims under the contract and in the performance of obligations imposed on the Controller by tax law, i.e. for a period of 6 years from the end of the year when the contract expired. The data processed for the purposes of direct marketing of our products may be processed until you object to their processing for this purpose.
